VISTA DE LA LUZ HOMEOWNERS' ASSOCIATION DELINQUENCY POLICY

Beginning May 1, 2017, we moved to a quarterly billing cycle.

Dues for May and June were billed on May 1st. Dues for each quarter thereafter were billed *in advance* on the first of each calendar quarter: July 1st, October 1st, January 1st and April 1st.

Dues are due <u>60 days</u> after the billing date.

Article VII of the Covenants, Conditions, & Restrictions require the placement of a lien on a property when dues are <u>30 days</u> past due. It also calls for interest at 12% per annum on delinquent balances.

<u>75 days</u> after the billing date (15 days after the due date), the Association will send an **Intent to Lien Letter** by certified mail. The property owner will be charged \$50.

<u>90 days</u> after the billing date (30 days after the due date), the Association will file a **Notice of Lien** with the Bernalillo County Recorder. A copy of the Notice of Lien will be mailed to the delinquent owner. The owner will be charged \$150. The Notice of Lien will not be released until the account is paid in full, including Interest and Notice of Lien and Intent to Lien fees and all other penalties and fees.

<u>150 days</u> after the billing date (90 days after the due date), the account will be turned over to an **attorney for collection**. The owner will be charged legal fees in addition to all fees already assessed.

When a property is sold, all unpaid amounts for dues, interest and fees are withheld from the seller's proceeds and remitted to the Association.

No owner may waive or otherwise avoid the liability for assessments by abandoning their property.

The charge for NSF checks is \$55.
